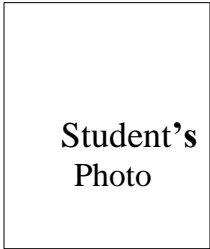

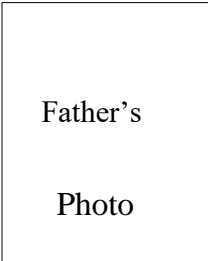

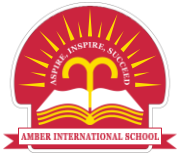

## TRANSPORT RULES

1. SCHOOL TRANSPORT WILL ONLY BE PROVIDED IN THE REGULAR SCHOOL TIMING & SCHOOLWORKING DAYS.
2. TRANSPORT FEE WILL BE CHARGED FOR FULL ACADEMIC YEAR. (TWO INSTALLMENTS).
3. PARENTS DESIRING TO DISCONTINUE THE TRANSPORT SERVICE ARE REQUIRED TO INTIMATE TO THE PRINCIPAL IN WRITING AT LEAST ONE MONTH IN ADVANCE OR PAY ONE MONTH'S BUS FARE IN LIEU THEREOF
4. IN CASE THE CHILD IS DROPPED BY THE PARENTS TO THE SCHOOL OR COLLECTED BY THE PARENTS FROM THE SCHOOL, THE FACT MUST BE BROUGHT TO THE NOTICE OF THE COORDINATOR AND CONCERNED DRIVER/CONDUCTOR THROUGH THE SCHOOL OFFICE/TRANSPORT INCHARGE.
5. NO STUDENT SHALL BE ALLOWED TO USE THE SCHOOL TRANSPORT ONE WAY. IN EVERY CASE TRANSPORT FEE WILL BE CHARGED FOR BOTH WAYS.
6. FOR ANY CHANGE IN THE BUS ARRANGEMENT WRITTEN REQUEST STATING ADEQUATE REASON SHOULD BE MADE TO THE SCHOOL OFFICE/TRANSPORT INCHARGE. CHANGE OF TRANSPORT ROUTE CANNOT BE CLAIMED AS A MATTER OF RIGHT. THIS WILL BE ALLOWED SUBJECT TO THE AVAILABILITY OF THE SEAT IN DESIRED BUS ROUTE.
7. TEMPORARY CHANGE OF ROUTE FOR A FEW DAYS CANNOT BE ALLOWED UNDER ANY CIRCUMSTANCE.
8. ONLY THE STUDENT WHO HAS BEEN ALLOWED TO AVAIL THE SCHOOL TRANSPORT WILL BE PERMITTED TO TRAVEL IN THE SCHOOL TRANSPORT AT THE STIPULATED TIME . ANY STUDENT LEAVING THE SCHOOL EARLY / LATE HAS TO BE COLLECTED BY THE PARENT/GUARDIAN.
9. THERE COULD BE AN INCREASE IN THE TRANSPORT FEE IN THE MIDDLE OF THE SESSION IF FUEL PRICE IS HIKED BY THE GOVERNMENT.
10. MANHANDLING OF SCHOOL STAFF BY ANY PARENT OR GUARDIAN UNDER ANY CIRCUMSTANCES WOULD BE CONSIDERED AS AN OFFENCE, IN SUCH CASES TRANSPORT FACILITY SHALL BE IMMEDIATELY WITHDRAWN AND ADEQUATE LEGAL ACTION SHALL BE TAKEN.
11. THE TRANSPORT FACILITY CAN BE WITHDRAWN IF THE STUDENT AVAILING THE TRANSPORT EXHIBITS ANY KIND OF INDISCIPLINARY ACT RISKING OTHER'S LIFE.
